TUITION POLICIES

June 12th - August 18th, 2023

Liberty Christian's **Summer in the Son** Summer Daycamp program provides all-day, Monday-Friday supervision for the care of your child by a fun, friendly, and mature staff. **This camp is designed for campers going into the 1st- 8th grade.**

**(camper must have finished a full-day Kindergarten program prior to this summer)**

While on campus, we engage the campers in daily Bible lessons, indoor and outdoor recreational activities, and group activities. While participating in off-campus field trips, your child will be transported by state-certified busses (on rare occasions your child may be transported via insured counselors or church personnel). The best part of our program is:

## WHAT IS COVERED IN THE COST OF TUITION:

- transportation for field trips
- admission costs to field trips
- supplies for games and activities

**\*LUNCH IS NOT PROVIDED - CAMPERS WILL NEED TO BRING THEIR OWN LUNCH DAILY**

**The cost for a week of daycamp per camper is a flat-rate fee of**  
**\$175.00.**

**2<sup>nd</sup> child discount..... \$165.00 a week**

**3<sup>rd</sup> child discount.....\$155.00 a week**

**(holidays, partial weeks, illnesses, vacations, etc. will not change the tuition rate, regardless of how many days your camper attends camp for the week)**

## **Registration Fee:**

There is a \$75.00 non-refundable Registration Fee per camper. This must be paid when the registration paperwork is turned in for you to be able to enroll your child. The two camp t-shirts are included in this fee.

#### HOURS

Daycamp is from 7:30am-5:30pm.

#### TUITION

We require that tuition be paid upon the **first day** that your camper attends camp for the week. That afternoon we will send home a tuition reminder slip if tuition still has not been paid. If by the second day you sign your camper in, there is still no payment, we will **apply a \$25 late fee** to your tuition. If by the completion of the second day, tuition still has not been paid, ***we will not allow your camper to participate in the remainder of the week's activities*** until both tuition and late fees have been paid. Tuition can be paid by cash, check (made payable to Liberty Christian Preschool) or by Credit Card (\*a 2.75% processing fee will be applied with credit card). Drop off your payments in the black metal lockbox that is located on the Sign-In/Sign-Out table. The fee for a returned check is \$25.00. Failure to pay these debts may result in your child not being able to attend camp.

#### SIGNING IN/OUT

We understand you've got your day to get to and want to get in and out as fast as possible. Having said that, we really need you, the adult, to be the one to sign your camper in or out of camp. Please don't send a sibling/friend to sign your camper out. Make sure your camper is being picked up by someone that is on the "approved pick-up" list that is located on your enrollment contract. If there is a situation that warrants adding another individual to your pick up list, please call the camp cell phone and inform a director. Always, always, always be prepared, (or prepare authorized pick-upees), to show their identification when signing campers out.

#### CONDUCT

We work hard to make sure this camp is family-friendly. We have some young ears listening, watching, and mimicking. Because of this we have a strict **no swearing, hitting, discourteous or dangerous conduct policy**. If your camper's conduct becomes an issue at camp, we will notify you with a "red note" on the message board. This is our discreet way of conveying the issue that occurred. Repeated misbehavior, or multiple red notes may result in a conversation with the director to the camper or the parents. If need be, the director may ask, at any given time, that your camper reveal the contents of his/her backpack. Thank you for your support and please follow-up with your camper. If you have questions about an issue that ensued, a red note, or any disciplinary issues please reach out to the counselor that signed the red note, or the director. Please do not speak to another camper about discipline issues.

#### DRESS CODE

We're all about being casual here at camp, but we're firm believers in modesty. While current trends directly contradict this, we will have to stick to our guns and insist that we all honor the modesty rules we have. Girls swimsuits must be a one-piece or a **long** tankini, or we will require that they wear a dark colored t-shirt over it. We are not big fans of the midriff; crop tops are not at all allowed at camp. Shirts with oversized armholes that allow the sides of the breasts to be seen are not allowed. The length of shorts must be at fingertip length: in other words, when arms are hanging loose at the sides, they can't be shorter than the end of their fingers. We're a flip-flop staff, but highly encourage you to invest in some stronger flip-flops; the kids love to run and those plastic ones break easily. We'll do our best to fix them, but please send your camper with the appropriate shoes for the day.

### CAMP T-SHIRTS

On your first day of camp you will receive your oh-so-fancy camp shirts! We have a **YELLOW** shirt that is dedicated to Tuesday beach trips. Why do we force the kids to wear their yellow shirts to the beach? Well come visit us at the beach and you'll see how great it is to see our sea of yellow kids clearly visible in our designated zone. You will also receive a **BLUE** Thursday field trip t-shirt. Every camper must be wearing the appropriate colored shirt for the off-campus days. If your camper is dropped off without their appropriate camp t-shirt on, we will give them another shirt and charge your account. Additional shirts may be purchased throughout the summer; yellow shirts are \$10/each and blue shirts are \$15/each. If you alter your camp shirt, please be mindful of camp dress-code rules.

### FIELD TRIPS:

- A. Campers should wear their yellow shirts over their bathing suits every Tuesday.
- B. Make sure your camper is dressed in comfortable clothing and comfortable shoes in addition to their blue camp shirts every Thursday.
- C. Campers will need sunscreen, and a reusable water bottle each trip we take.
- D. Make sure you are ON TIME for the trip; please follow the times indicated on our 1/2 sheet for the day; actually we'd prefer you were 15 minutes early.
- E. **We will not wait for campers:** if the bus is moving, it's moving. Please be on time and resist following us to the field trip. If you're late, most likely tickets have already been purchased and this will create a bit of a mess.
- F. We love our parents! You are welcome to join us on our field trips as a chaperone. Let the director know if you are interested in coming with us so that we can get you a discounted ticket. (Parent is responsible for paying for their own ticket; you can write us a check and drop it off in the black lockbox.)

### LATE PICK-UPS

We close promptly at **5:30PM** (excluding late busses of course). We do have a late fee which is **\$1.00 per minute per camper** not picked up by this time. Parents should pay the Summer Day Camp workers directly at the time the camper is picked up. If a payment is not made at that time, the amount will be added to your account's balance along with an additional \$10.00 processing fee, all of which will need to be paid with the next tuition check. If these debts are not taken care of in a timely manner, your camper may not be able to continue attending camp.
